

## ***Personal Watercraft (PWC) Offense Types<sup>1</sup>***

The table below is meant to be a quick-reference guide for common offenses involving PWCs. An individual may be subject to exceptions found within the relevant statutes, and accordingly, may not be guilty or responsible for the offense when certain conditions are met. See each statute in its entirety for information on circumstances in which an offense may not apply.<sup>2</sup>

<a href="#">MCL 324.80205(3)</a>	Operation of PWC with unaccompanied child under 7 years of age	Misdemeanor

MCL 324.80218(2)	Dealers of PWC - failure to provide to buyer documentation regarding PWC laws and safety features	State civil Infraction
